Traverse Open: only 15 signed up to date.


NEW BUSINESS:

Motion to adjourn meeting by Tom Nesbitt, seconded by Terry Humiston - approved.

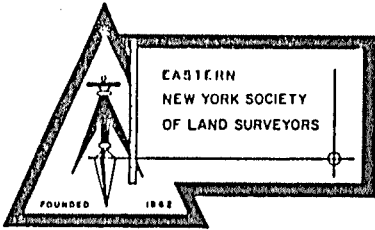
