EASTERN NEW YORK SOCIETY OF LAND SURVEYORS BOARD OF DIRECTORS MEETING October 10, 2024

The Mill Round Lake, NY

President Meisler called the meeting to order at 5:43 p.m.

Present: Brie Meisler, Timothy Huggins, Dwayne Cooper, James Vianna, Luke Richardson, Kaleb Winters, Ralph Hill, Dave Schmidt and Richard Palmer.

Secretary's Report: Dwayne Cooper

• Dwayne presented the September proposed meeting minutes. A motion to accept the September meeting minutes was made by Dave Schmidt, seconded by Rick Palmer. A vote was held, and the motion passed.

Treasurer's Report: Jim Vianna

- Jim provided an update on the LPL account balance and the Bank account balance.
- Jim reported that we had income of \$240 from August dues and \$30 from Jason Tommell and expenses of \$159 for Conference Journal ad and \$736.35 for the September membership meeting.
- Jim reported that he had seen on Rensselaer County IQS that people can put a fraud alert on their parcel.

- 9/20/2024 NYSAPLS BOD meeting
- Jeremy Thompson made a call for committee members
- Decision was made to drop to only 1 workshop this year for budget reasons, and there was discussion as to whether the full day workshops had value for membership. The attendance has been dropping while webinar member ship increases.
- At the time of meeting 341 of 1245 renewal invoices were unpaid. Asked us to reach out to membership.
- Second showings of webinars will be offered March 13, and September 11 next year.
- Conference committee is recruiting exhibitors and sponsors and mentioned strong interest from exhibitors this year.

- During discussion of the surveyors social, it was suggested that induction of the executive board happen in front of membership, possibly at keynote, rather than at the social which is a more expensive event.
- By-laws committee is working on a best practices document and also a template for regionals that don't by-laws or don't have up to date by laws.
- They are soliciting comments on the by-laws revisions. There have been updates to membership categories and updates to allow electronic voting.
- Workforce development committee is creating and gathering resources to organize into a website that volunteers and can use to attend events.
- Government relations committee is attending Geospatial Summit. Current focus is on online access to county clerk's. Counties that have navigated and funded the shift to digital access are sharing with other counties how it was done.
- NYSDOT is changing their referencing system for pulling takings.
- NYS GIS introduced a surveyor's app, but it isn't great. They have invited NYSAPLS to be on the committee.
- At the State Board meeting, NYSAPLS was a big topic. They are pleased with the efforts of the Young Professionals committee
- State Board has finally started reviewing MTS and have asked for more background on what other states' standards look like.
- The next strategic planning retreat is being planned and they are asking for regionals to keep in mind associates to send.
- For those of you who haven't attended a retreat or NYSAPLS BOD meeting, the strategic plan is a very practical document. They set goals, and assign those goals to committees, and the committees work on them.
- With work force development taking over some of their items, Young Professionals committee has shifted goals and is focusing on helping young professionals already in the industry. Some items include help with the application process and podcast interviews with niche surveyors. Jason spoke about the Skills Bridge program.

- Northern board members said the policy was adopted by a vote, not by a by-laws amendment.
